

- el. All manufacturers should meet the eligibility criteria.
- 2. All the raw materials will be offered for stage inspection to the concerned DQA.
- 3. The firm shall produce documentary evidence at the time of inspection that they have used only ISI marked MDF Board, Particle Board, Pre-laminated MDF board, Pre-laminated particle board and Decorative Thermosetting Synthetic Bonded Sheets
- 4. Firms must submit their application to concerned DQA office for fresh or renewal of registration/capacity assessment/special capacity assessment PRIOR to at least 30 days before scheduled date of tender opening, failing which application may not be possible to be processed before tender opening date and only tenderers will be responsible for the same.

Tenderers shall be registered with DGS&D or NSIC(based on capacity report of DGS&D) as per current T/E to become eligible to quote against the same.

- 5. One sample of each item shall be got approved from concerned DQA before starting of bulk supply and be retained by the firm during the currency of contract and for a period of one year after the contract.
- 6. The firms shall furnish manufacturer; T/C along with R/Material invoices at the time of inspection. Further, the participating firms should have in-house testing facilities in respect of IS: 5967 (Part-1&2)/1988 except for `Fatigue Test; which has been exempted.
- 7. Table Top having Decorative Thermosetting Synthetic Resin Bonded Laminated Sheets will be of nomenclature HPL- IS2046 P 323 and will meet the testing requirements of IS 2046/1995 (Reaffirmed 2005) Edition 3.1(second revision) incorporating amendment No. 1 of colour/shade/ finish required by the indentor at the time of placement of supply order
- 8. Stores will be supplied in knock down condition duly packed in such a way that it should take care of all the transit hazards without any damage and will be assembled at consignee place within one month from date of receipt of stores by the consignee. The supplier shall ensure the inter-changeability of parts of items. The interface layer of two boards should have a corrugated sheet of suitable not less than 5 mm thickness and the metal items should be packed separately
- 9. Packing should be strong enough to withstand a drop test on its edges from a height of 1.0 Meter. The items shall be stored in packs on a level flat surface in a clean, dry and covered place with free circulation of air. The boards shall be protected from rain, dampness and fungal attacks. Finally stores shall be packed in a wooden cage and the packs shall be kept clear of the floor.
- 10. Thickness of electro galvanizing should be between 20 to 30 micron and thickness of powder coating should be 40-micron minimum.
- 11. During testing of stores sampling plan of Table 3 of IS 5967(Part 1) /1988(Reaffirmed 2002) (First Revision) shall be followed.
- 12. Units will be complete with all necessary fittings and fixtures, Drawer handles of 100 mm duly chrome plated shall be provided on each drawer.
- 13. Preservative Treatment of Particle Boards and Medium Density Fibred Boards shall be as per Clause 6.3 of IS 3087/2005(Second Revision).
- 14. Each product shall be legibly marked near any of its corners with the following: -
